APPLICATION TO EXCEED A SCREENING LEVEL

Producers wanting to exceed a screening level must complete and sign this application and provide a certified accountant's or lawyer's letter verifying ownership and family relationship (if any), and submit it to Dairy Farmers of Ontario (DFO) for approval. The letter is required for all business structures – sole proprietorships, partnerships or corporations. For corporations, the letter must also indicate who has the authority to bind the corporation. If the authority to bind the corporation is not indicated, all shareholders must sign the form.

All forms must be received at DFO on or before the last working day of a month to be eligible to bid on the exchange ending the first day of the next month.

The ownership information provided by the certified accountant or lawyer must match the ownership information DFO has on file for the application to be processed. If the ownership information does not match, contact your DFO Field Services Representative to obtain the necessary forms.
